Finance Report:

- Airport and Treasurer financial Reports presented by Jeff Benton- audit will be June 16th, 17th, and 18th.
 - Benton said expenses were quiet but little revenue came in from state/county.
- Water Works financials were presented by Mayor Leonard Rodenbur.
 - Expenses for month were small and water works accounts have finally started rising to levels that gives the account good stability. However, some large expenses are still to come.
- Unpaid bills were presented for approval.

Water Works Report

- Dan gave report and updates on lift station and water break on main street the county is suppose to bring in new dirt/material to fill the hole. Dan will remove the old dirt and sections of the broken asphalt. Best case at this time was end of March start of April to have the street repaired.
- Dan talked about what Maguire Iron did repairing the city water tower
- Rodenbur talked about the cost and prospect of doing an interior refurbishment and exterior overlay of the tower. Will look into cost and possible grant opportunities

City Clerk

- Rodenbur went over three shut offs that will be done Tuesday morning if no payment comes in this evening.

Streets

- Discussion on streets. Rodenbur will start getting estimates on repairing 2nd street.

Zoning

- Discussion on zoning updates. Zoning committee approved the changes to the zoning ordinance book. Discussion about zoning and having Rodenbur go talk to the county about getting the division of zoning sections.

Old Business


- Rodenbur is still working on updating the ordinance book and cleaning it up .
- Discussion of the new Animal Control officer and the adoption of both Ingalls sheltered dogs.


New Business:
