- Gray Co Sheriffs department offered \$800 for the radar.



**Donella Snyder motion to buy the TC400A radar sign, Stacy Reist seconded the motion; motion carried and approved by all.**


**Stacy Reist Motion to adjourn at 7:45pm and Tina Marquez seconded the motion, motion carried and approved by all.**
