- Discussion on proposal to buy gift cards for members and employees of the City


Vickie Trevino motioned to get gift cards for council members and employees, Larry Hayes seconded the motion; motion carried and approved by all

- One council member resigned.


Larry Hayes motioned to accept resignation of council member, Vickie Trevino seconded the motion; motion carried and approved by all
