Motion was made by Larry Hayes to get surveillance cameras, Vicky Trevino seconded the motion; motion carried and approved by all.




1. Discussion on ordinance on establishing a program for rehabilitation of abandoned property

Motion was made by Larry Hayes to get the Single Hole Sponsor, Vicky Trevino seconded the motion; motion carried and approved by all.


Motion to adjourn was made by Donella Snyder @ 9:45 and Vicky Trevino seconded the motion, motion carried and approved by all.
