New Business


- EBH is working on easement for waterline going up to O'Neal edition

Jeff Gilbert motioned to move council meeting start time from 7pm to 6pm, Larry Hayes seconded the motion; motion carried and approved by all.


Donella Snyder Motion to go into executive session at 9:23 and Larry Hayes seconded the motion, motion carried and approved by all.

Next Meeting is scheduled for June 14th, 2021 at 6:00PM


